


- 一个以太网 RJ-45 接口 (10Base-T/100Base-TX)
- 至少一个支持无线功能的 IEEE 802.11b/g/n 设备
- · 一台已安装 TCP/IP 与网络浏览器的电脑

开始安装之前

安装华硕无线路由器之前,请注意以下几点:

- 连接设备与网络(网络集线器、ADSL/Cable Modem、路由器)的网线 长度须小于 100 米。
- 将设备放在平坦、稳定的地方,并尽量靠近地面。
- 请勿将设备放在靠近金属物品与阳光直射的地方。
- 请将路由器远离适配器、重型发动机、荧光照明器、微波炉、冰箱与其他工业设备以防信号丢失。
- 建议将路由器放置在中心区域,以覆盖所有无线移动设备。
- 请将路由器放置在远离人体至少 20 厘米的地方。







安装路由器

华硕无线路由器可安装在高处的平面上,如衣橱或书架上,也可以固定于墙上或天花板。

请依照以下步骤安装华硕无线路由器:

- 1. 找到路由器底部的两个安装挂钩。
- 2. 在墙上或高处的平面上标注两个孔位。
- 3. 将两颗螺丝拧紧直到只露出 1/4。
- 4. 将无线路由器挂到墙上的螺丝上。





注意:若螺丝太松或无法将华硕无线路由器挂到螺丝上,请调整螺丝位置。



设置无线路由器

华硕无线路由器包含一个网页图形界面(Web GUI),您可以利用电脑上的网络浏览器进行无线路由器的设置。



路由器连接时请注意:

- 1. 通过网线将调制解调器连接至路由器的 WAN 接口。
- 2. 通过另一根网线将您的电脑连接至路由器的 LAN 接口或您的电脑通过无线连接至路中架。
- 3. 当路由器连接电源后,请稍等,直到电源灯亮起,WLAN 灯开始闪烁,LAN 灯亮起,WAN 灯亮起以确认路由器系统完全启动。



访问无线路由器

为有线或无线客户端设置一个 IP 地址

为使用华硕无线路由器,您的有线或无线客户端上必须有正确的 TCP/IP 设置。请确认客户端的 IP 地址与华硕无线路由器一致。

华硕路由器内置 DHCP 服务器功能,当系统开启时,它将自动分配 IP 地址到网络中的客户端。

但在某些情况下,您可能需要手动指定某些您网络内的客户端或电脑的静态 IP 地址,而不是通过您的无线路由器自动取得 IP 地址。



服务质量(QoS)允许您设置带宽优先级并管理网络交通。

在"无线网络桥接器"中,无线路由器从连接到 WAN 端口的路由器收 到 WAN IP 地址,并为用户提供无线信号。NAT、 防火墙与 IP 分享服务 会主动关闭。

请依据以下步骤设置"无线网络桥接器"中的无线路由器:

- 1. 在导航菜单中点击【高级设置】>【系统管理】>【操作模式】。
- 2. 选择【无线网络桥接器】,并点击【保存】。



3. 输入你的网络名称(SSID)与网络密钥。完成后点击【完成】。



侦测设备(Device Discovery)

Device Discovery 是一款华硕 WLAN 应用程序,可以侦测到一个华硕无线路由器设备,并且允许您设置该设备。

请依照以下步骤开启 Device Discovery 应用程序:

在您的电脑桌面上选择【开始】>【所有程序】>【ASUS Utility】>
 【RT-N12E Wireless Router】>【Device Discovery】。



- 选择【配置】进入网页图形界面来设置无线路由器。
- 选择【搜索】来搜索华硕无线路由器。
- 选择【退出】退出此应用程序。

固件恢复(Firmware Restoration)

Firmware Restoration 应用程序用于在固件升级失败时搜索升级失败的华硕无线路由器,然后恢复或上传您指定的固件。此过程需要 3 至 4 分钟。



重要:在使用 Firmware Restoration 之前,请开启救援模式。

请依照以下步骤开启救援模式并使用 Firmware Restoration 应用程序:

- 1. 拔掉无线路由器的电源。
- 2. 持续按住后面板上的重置按钮,同时把路由器重新接上电源。当前面板上的 WPS 灯开始慢闪时,放开按钮。此时,路由器已进入救援模式。
- 3. 在您的电脑桌面上选择【开始】>【所有程序】>【ASUS Utility】>【RT-N12E Wireless Router】>【Firmware Restoration】。



4. 选择固件文件,然后选择【上传】。
