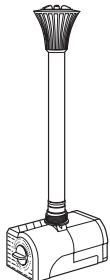

For safety reasons, children under the age of 16 and people not familiar with these operating instructions must not use this Indoor Indoor Fountain Pump.

# 1. Where to Use Your GARDENA Indoor Fountain Pump

## *Correct use:*

GARDENA Indoor Fountain Pumps have been designed for private use around your house. They are not designed for operating watering tools and systems. Pumps RP 240 / RP 300 / RP 600 must only be used indoors. Pump RP 420 is part of Fountain Set Art. 7767 and is suitable for outdoor use.

## *Please note:*



**GARDENA Indoor Fountain Pumps have not been designed for constant use in the industrial sector. Corrosive, easily combustible, aggressive or explosive substances (e.g. petrol, petroleum, nitro thinner) as well as saltwater or food / drinking water must not be pumped.**

## 2. Safety instructions

### *Electrical safety:*



**DANGER! Electric shock!**

→ **Always disconnect the fountain pump from the mains before undertaking any work.**

The pump should be operated via a residual current device with a residual current rating of  $\leq 30$  mA (DIN VDE 0100-702 and 0100-738). The pump must be placed on solid, even ground.

→ Please consult a qualified electrician for advice.

Mains power cables must not have a smaller cross-section than a PVC cable of the designation H03 VV (RP 420 of the designation H05 RNF). Extension cables must meet the requirements of DIN VDE 0620.

Data indicated on the type plate must match technical data of the mains supply.

Please unplug the fountain pump after operation and before carrying out any maintenance works.

The fountain pump must not be operated when there are people in the water.

Swimming pools and garden ponds should be designed according to international and national design regulations.

→ Please consult a qualified electrician for advice.

Before operating the fountain pump, look to see if there is any damage to the fountain pump (esp. regarding power cable and plug).

The connection cable of the pump cannot be

replaced. If the cable is damaged the pump must be disposed of.

Do not use the power cable to carry the pump or to pull the plug out of the socket.

Protect the power cable from heat, oil and sharp edges.

***For Austria:***

Pumps for use in swimming pools and ponds may only be operated via an isolating transformer.

→ Please consult a professional electrician.

***For Switzerland:***

In Switzerland mobile appliances which are used outdoors must be connected via a residual-current device.

***User instructions:***

**Never let the pump run dry; running dry generates heat and will damage the pump.**

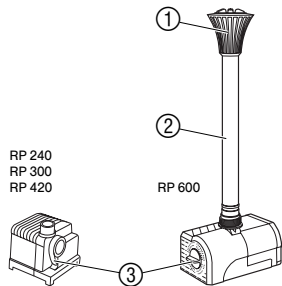
The temperature of the liquid used must not be below 4 °C or above 35 °C.

Sand and other abrasive substances in the liquid cause increased wear and reduce the output of the pump.

Please observe the local noise prevention regulations.

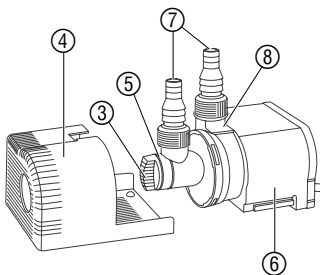
### 3. Initial Operation

#### Starting up the pump:



1. RP 600: Insert the fountain socket ① and nozzle tube ②.
2. Install the pump at ground level so that the filter housing is standing in water to at least half its height (with pumps RP 240 / RP 300 / RP 420 make sure that the sides of the foam filter under the pump are not blocked).
3. Plug mains plug into an AC power socket.  
**Warning: Pump will start immediately.**
4. Use the flow control ③ to set the desired water flow for the fountain pump.

**Commissioning the pump if  
it is installed out of water:**



If the pump is installed out of water, the filter housing ④ must be taken off.

1. Pull off the filter housing ④.
2. Turn the pump inlet ⑤ anticlockwise and pull it vertically off the motor housing ⑥ (bayonet socket).
3. Depending on the pumping application, the pump inlet can be rotated in 90° steps. Twist the pump inlet ⑤ accordingly, again press it vertically on to motor housing ⑥ and tighten it clockwise (see 5. Cleaning).
4. Screw stepped nipples ⑦ on to the pump inlet ⑤ and pump outlet ⑧.
5. Connect the pump inlet ⑤ to the water reservoir with a hose (1/2" or 3/4"). **The level in the water reservoir must be higher than the pump inlet ⑤.**
6. Connect the pump outlet ⑧ to the spring / gargoyles with a hose (1/2" or 3/4").
7. Fill the hose to the pump inlet ⑤ with water.
8. Insert the pump plug into a mains socket.  
**Caution: The pump will start immediately.**
9. Use the flow control ③ to set the desired water flow for the spring.

## 4. Storage

### Storage:



The fountain pump must be stored out of the reach of children.

1. Before the frosty season begins, ensure the fountain pump has been cleaned and is stored indoors.
2. To avoid difficulties when starting up in the spring, we recommend storing the pump in a frost-free location in a container filled with water.

*The mains plug must not be submerged.*

### Disposal:

*(in accordance with  
RL2002/96/EC)*



The product must not be added to normal household waste. It must be disposed of in accordance with local environmental regulations.

## 5. Cleaning



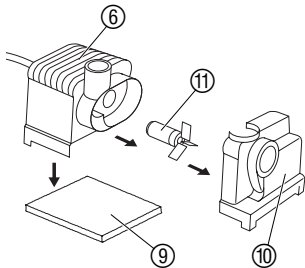
**DANGER! Electric Shock!**

**Risk of injury due to electric shock.**

**→ Before cleaning the pump, unplug it from the mains.**

**Do not use any hard tools or aggressive cleaners on the pump.**

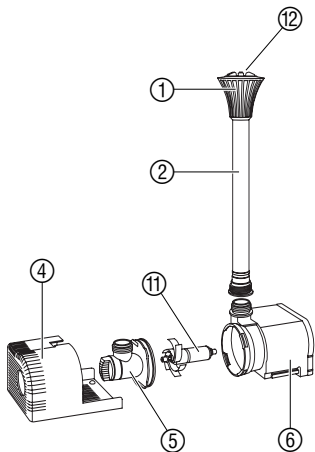
***Cleaning the  
RP 240 / 300 / 420:***



1. Remove foam filter ⑨ by pulling down and clean it.
2. Push off the pump housing ⑩ on the pressure spigot of the motor housing ⑥.
3. Take the impeller ⑪ out of the motor housing ⑥ and clean it.
4. Push the cleaned impeller ⑪ back into the motor housing ⑥.
5. Push the pump housing ⑩ back onto the motor housing ⑥.



## Cleaning the RP 600:



1. Pull off the fountain socket ① and nozzle tube ②.
2. Unscrew the fountain insert ⑫ and clean it.
3. Remove the filter housing ④ from the motor housing ⑥, and clean it.
4. Turn the pump inlet ⑤ anticlockwise and pull it vertically off the motor housing ⑥ (bayonet socket).
5. Take the impeller ⑪ out of the motor housing ⑥ and clean it.
6. Push the cleaned impeller ⑪ back into the motor housing ⑥.
7. Push the pump inlet ⑤ vertically onto the motor housing ⑥ and tighten it clockwise. (If the pump is to suck from underneath, the thread must face downwards).
8. Push the filter housing ④ back on to the motor housing ⑥.
9. Screw the desired fountain insert ⑫ into the fountain socket ①.
10. Plug the fountain socket ① and nozzle tube ② back into place.

## 6. Troubleshooting



**WARNING! Electric Shock!**

**Risk of injury due to electric shock.**

**→ Disconnect the fountain pump at the mains before rectifying any faults.**

<b>The pump delivers no water</b>	Mains plug not plugged in.	→ Plug in the mains plug.
	Impeller unit is blocked.	→ Clean pump.
	Impeller running in the wrong direction due to insufficient water.	→ Disconnect from the mains and top up with water.
<b>The pump delivers a reduced water flow</b>	Foam filter / filter housing dirty.	→ Clean the foam filter / filter housing.

### *Warranty*

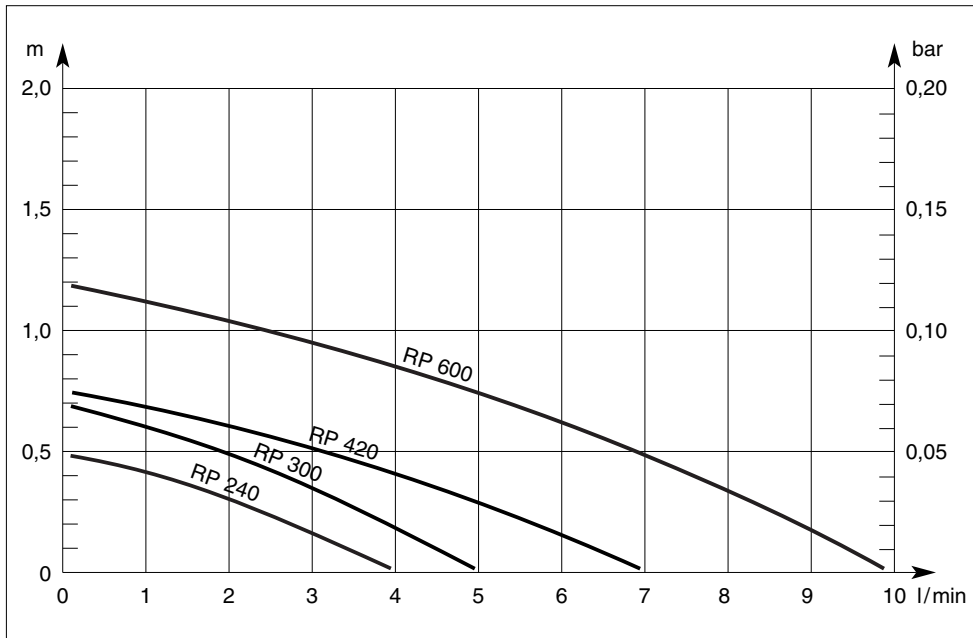
